

MOMENTUM IS BUILDING FOR NATIONWIDE, YEAR-ROUND E15 LEGISLATION

HERE IS WHAT THEY ARE SAYING...

PRESIDENT TRUMP

- “I promised to support E15 all year-round. I am trusting Speaker Johnson and Leader Thune to find a deal that works for farmers, consumers, and refiners, to get E15 approved. And they’ll be sending me a bill very shortly supporting year-round E15, to my desk very quickly, and I will sign it without delay.” — **President Donald Trump**

U.S. SENATE

- “I have been a steadfast advocate for the year-round sale of E15... Implementation of year-round E15 would be a huge win for South Dakota producers and would boost the agriculture economy and rural communities across the nation.” — **Sen. John Thune (R-SD), Senate Majority Leader**

- “A patchwork of emergency fuel waivers does not provide certainty. ... Not only do biofuels drive demand for our crops, but they play a crucial role in our energy security. There are several ways before us that Congress and the administration can and should **take action**, and they should take it **immediately.**” — **Sen. Deb Fischer (R-NE)**
- “Let’s start with getting year-round E15 done permanently. It’s hard to find someone who opposes it, yet you can’t get it done. What I would like to see is, as we move a farm bill forward, we can find a way for year-round E15 to ride along.” — **Sen. Tina Smith (D-MN)**

U.S. SENATE

- “In his recent trip to Iowa, President Trump backed Iowans and endorsed E15. He committed to signing year-round E15 into law, and he called on the House and Senate to **pass legislation soon**. Trump understands the clear benefits of E15. It’s good for the farm economy, lowering gas prices, the environment and America’s national security. E15 is good, good, good.” — **Sen. - “Prioritizing homegrown biofuels and year-round E15 encourages job growth, ensures future markets for our farmers, strengthens our national security, reduces gas prices, protects the environment and secures our nation’s leadership in the energy sector for years to come. ...If they wanted to get this done, it would be done.” — **Sen. - “We are going into our third year now where people (corn farmers) are losing money... You just cannot continue to do that year after year. So, finding new markets for our corn like E15 has a big potential impact to help our farmers in the near term and that is why we are going to continue to push for it.” — **Sen. Pete Ricketts (R-NE)**
- “(Year-round E15) is a big deal to Michigan. Can we just do it? I thought we were getting close. I thought there was a moment. **Let's just do it**. It's so good, and good for the consumers. Good for our farmers. It's a good deal.” — **Sen. Elissa Slotkin (D-MI)**
- “Congress should be looking at every opportunity to expand American biofuel consumption. And we need to make sure that infrastructure requirements don't stand in the way of offering E15 to those who want a cheaper fuel source. President Trump has already asked Congress to deliver a bill to his desk, and it's **really well beyond time to act**.” — **Sen. Joni Ernst (R-IA)**
- “I think this is our **top goal**. ...this is so important, and it was great to see the President lean into the issue publicly. If we went to E15, this could mean another 2 billion bushels of corn consumed. We usually export about that much, so it’s almost like doubling our exports without having to go through the drama of dealing with China and some of those other countries.” — **Sen. Roger Marshall (R-KS)**

U.S. HOUSE OF REPRESENTATIVES

- “I think everybody understands the **urgency** with which we have to act—the president has said **we need to get E15 done** and we’re going to figure out a way to do that.” — **Rep. Mike Johnson (R-LA), Speaker of the House**
- “You've got my commitment to work on year-round E15. **It needs to get done**. I also think the time's right for it. It's good for everybody.” — **Rep. GT Thompson (R-PA), Chairman, House Ag Committee**

U.S. HOUSE OF REPRESENTATIVES

- “Renewable fuel is very, very important. We have got to start expanding domestic markets in our country. We are **long past time** for the conversations that we should be having on year-round E15...” — **Rep. Angie Craig (D-MN), Ranking Member, House Ag Committee**
- “I’ve been advocating for this for years. The good news for ag country is that you’ve got a lot of allies. There’s a lot of people who understand the importance of year-round E15, and I think **we’re going to see it.**” — **Rep. Tom Emmer (R-MN), House Majority Whip**
- “We **need certainty** for farmers and lower prices at the gas pump. We had an opportunity to do both of those things by allowing the year-round sale of E15 nationwide to be included in the farm bill. - “For too long, unscientific and misguided government red tape has blocked year-round access to E15 and sowed regulatory uncertainty. It was President Donald Trump’s first administration that paved the way for a waiver permitting summertime sales in a handful of midwestern states, and **it is well past time that we provide market certainty through law.**” — **Rep. - “Kansas farmers grow it. Drivers need it. Yet Congress is dragging its feet. It’s time to approve year-round E15 so we lower gas prices and support local producers. Stop stalling. **Let’s get it done.**” — **Rep. Sharice Davids (D-IL)**

FARM GROUP LEADERS

- “Year-round access to E15 is **critical.** Farmers have **waited far too long** for this simple deregulatory bill to be passed. We have the support of the large majority of the fuel sector, and the President has pledged several times over that he will sign legislation granting year-round E15 access **once Congress gets it across the finish line.** A lot of farmers are looking for a way to make a profit. - “We’ve been surviving on summertime E15 emergency waivers for five years now. At some point, that becomes untenable, and then I don’t know what happens...We have a lot of members who sell E15 at thousands of locations, but only being able to sell the product **part of the year** is a **real problem**, administratively and otherwise.” — **Doug Kantor, General Counsel, National Association of Convenience Stores**
